## Extract from three documents submitted by Solicitor Adrian Mueller to Supreme Court Cost Assessor for his alleged legal work in NCAT case SC 20/33352 on 25 March 2022

On 8 March 2022, Lot 158 visited NCAT offices. They found out that there was NO EVIDENCE of alleged Solicitor Adrian Mueller's correspondence with NCAT in December 2020 and January 2021, and when Solicitor was directly challenged to prove his costs to Supreme Court and Lot 158, he stayed silent and did not address the comprehensive questions sent to him on 27 February 2022, 31 March 2022, 5 April 2022, and 20 April 2022.

#### Three options:

- a) Tribunal destroyed Solicitor Adrian Mueller's correspondence with NCAT, which, as per Lot 158's paid document search is HIGHLY ILLEGAL and amounts to CRIMINAL ACTIVITY, or
- b) Solicitor Adrian Mueller mislead (lied to) Tribunal, never offered evidence of his retainer made at any legally-convened general meeting of SP52948 owners corporation, and coerced Senior Member Sarginson to allow him to attend the Hearing on 11 February 2021 (certified audio recording of the Hearing obtained by Lot 158 can confirm that Solicitor Adrian Mueller stayed silent and declined to respond to questions of validity of his attendance on 11 February 2021), or
- c) Tribunal hid Solicitor Adrian Mueller's correspondence with NCAT, which prevents Lot 158 and Office of Legal Services Commissioner (or any other law-abiding citizen, including ICAC, insurance company, and Police) to investigate serious misconduct.

Solicitor Adrian Mueller provided three versions of his alleged actions in relation to NCAT 20/33352 and in each version, he listed correspondence with NCAT which has not been found.
