As a condition of your appointment, you are considered to be the <u>Principal Contractor</u> where the works undertaken meet one or more of the following criteria:

- The cost of the works exceeds \$250,000
- The work is high risk construction, renovation, repair or remedial building maintenance works undertaken on common property
- The work involves demolition
- The work involves asbestos removal for which a license is required under Clause 210 of The OH&S Regulation 2001
- The work involves working at heights of above 3 metres or 1.5 metres below ground.

Notes: A Safe Work Method Statement MUST cover the following:

- Description of how the work is to be carried out
- Identifies the work activities assessed as having safety risks
- Identifies the safety risks
- Describes the control measures to be applied to the work activities
